## **DISPATCHER ACTIVITY**


- In 2022, the Darke County Communication's Center was staffed with eight full time dispatchers, two trainees, four part time dispatchers and one 911 coordinator. Our staff dispatched for the Sheriff's Office, four police departments, nine EMS agencies, and seventeen Fire Departments. Communications staff is responsible for answering and processing emergency and non-emergency calls for law enforcement, fire and emergency medical services throughout the county, and dispatching appropriate units to those calls. They also monitor and track the status of public safety personnel; synchronize responses with other communications centers; and receive and process civil paperwork, including warrants and protection orders.
- 14,392 911 calls were received by the Darke County Communications Center in 2022,
   with an additional 27,139 calls received on the non-emergency line
- The Darke County dispatcher's average answer time is 3.4 seconds, with 99.80% of 911 calls answered within fifteen seconds. This exceeds the standard set by the State of Ohio of 90% of 911 calls answered within fifteen seconds.
- Emergency Medical Services were dispatched 6,422 times
- Emergency Fire Services were dispatched 1,419 times
- 442 new warrants issued by the courts were entered in to LEADS with 365 total warrants being served
- 40 Civil Protection Orders and 33 Temporary Protection
   Orders were entered and maintained by the dispatch team



#### LAW ENFORCEMENT ACTIVITY

- Darke County has deputies on the road 24/7 to locate unlawful activities of all types and enforce those laws being violated.
- 396,090 miles were patrolled by our Road Deputies in 2022
- Deputies and detectives handled 11,302 calls for service while investigating 3,103 total reports
- Deputies attempted or served civil paperwork 3,078 times
- 1,352 traffic stops were initiated which resulted in 783 traffic citations
- The Sheriff's Office investigated 790 traffic crashes resulting in:
  - 11 fatal crashes where 14 individuals died
  - 33 crashes where persons sustained serious injuries
  - o 91 crashes with individuals claiming minor injuries
  - o 50 possible injury crashes
  - o 607 property damage crashes
  - 253 Car/Deer Accidents
- The Sheriff's Office also provides law enforcement services, security, and crowd control for special events such as county fairs, concerts and other events

### **K-9 ACTIVITY**

- In 2022, the Darke County Sheriff's Office employed 3 canines partnered up with deputies to serve their community. The canines go through rigorous training in order to search for individuals who have committed crimes, locate lost children and adults, search for articles, and to locate drugs
- The canines also respond to any department or jurisdiction in need. They are also utilized by the schools and jail.




- The K-9 team of Annie, Bear, and Oakley were utilized in 125 incidents in 2022
- K-9 Oakley was deployed 7 times to help locate individuals. Oakley was successful 5 times, with 2 of those tracks resulting in arrests. Oakley was also deployed on 11 traffic stops where he alerted to items 3 times
- K-9 Annie was deployed for tracks on 13 occasions in Darke and surrounding counties.
   Annie was successful 3 times, which resulted in 2 arrests
- K-9 Bear was utilized 94 times in 2022. On 43 deployments Bear was successful in alerting to drugs like methamphetamine, fentanyl, marijuana and cocaine. Bear was also involved in searches where 3 individuals were arrested





#### **JAIL**

- The Darke County Criminal Justice Center is a 36 bed jail just outside of Greenville
  Ohio. The jail division not only oversees the housing of inmates, but also the transport
  of inmates to the courts as well as to and from other jail locations. An assortment of
  self-improvement, food services, medical and mental health services are available to
  those incarcerated.
- 866 individuals were booked in to jail in 2022, up from 796 in 2021
  - o 674 were males, 192 females
- On average 30.5 inmates were housed per day
- On average 2,782 meals were served a month, with 33,398 total meals served 2022
- The average cost for a meal served was \$1.83





#### **SHERIFF SALES**

- The Sheriff is responsible for the court ordered sale of real estate that has been set for auction for nonpayment of taxes or failure to pay the mortgage
- In 2022, 50 properties were advertised in the Early Bird Newspaper and on www.darkecountysheriff.org. Of the 50 advertised, 24 were cancelled prior to the sale
- In 2022 this office launched an online auction site to conduct the sale of all real estate subject to foreclosure. Pursuant to House Bill 390, this new process was in accordance with a contract between RealAuction and the Ohio Department of Administrative Services



## SEX OFFENDER/ARSON REGISTRATION

- The Sheriff is mandated by law to register all sex and arson offenders who either live or work in their county
- In 2022, the Sheriff's Office tracked 90
  Registered Sex Offenders, 4 Registered
  Arson Offenders and 1 Registered Violent
  Offender
- The Sheriff's Office is also tasked to determine whether an offender has complied with state law in choosing an area of residence.
- In 2022, 470 Sex Offender Verifications were made
  - 185 Address Verifications
  - 101 Quarterly Verifications
  - 132 Semi-Annually Verifications
  - 53 Annual Verifications



#### CONCEALED HANDGUN LICENSING

- Darke County has one deputy assigned to overseeing the CCW process and Background Checks for residents of Darke County and/or adjoining counties.
- 496 renewal permits were issued with 96 new permits issued
- 4 permits were suspended with 0 being revoked
